COURSE OUTLINE CONTINUED

Day 1: Class based - Required knowledge (Practical training)

ASSESSMENT

Formal assessment shall be conducted when the candidate has completed their own self-assessment and in conjunction with the client it is agreed the trainee is ready for assessment.
